1. Introduction

Danish National Research Foundation: *Center for Subjectivity Research* was established at the Faculty of Theology, University of Copenhagen on March 1, 2002. The Center is financed by the Danish National Research Foundation with supplementary funding from the University of Copenhagen and Hvidovre Hospital for the period 01.03.2002 – 30.06.2006.

The aim of the Center is to undertake a thorough and comprehensive investigation of what might be considered the three fundamental dimensions of subjectivity: Intentionality, self-awareness, and intersubjectivity (i.e., subjectivity in its relation to the world, to itself, and to others). The research focuses in particular on the question of whether subjectivity can be naturalized. The Center emphasizes interdisciplinary approaches and draws on philosophy of mind, philosophy of religion, and psychopathology and it explicitly seeks to further the dialogue not only between different philosophical traditions (phenomenology, hermeneutics, analytical philosophy of mind) but also between philosophy and empirical science.

Although part of 2002 was spent on practical issues, such as arranging the physical facilities, advertising positions, hiring staff, designing the website, establishing the daily routines etc., extensive research activities were also initiated. During the first 10 months of its existence, the Center has organized 2 conferences (with a total of 20 speakers) and 13 guest lectures by invited speakers. Its scientific personal has published 38 books and articles, submitted 26 manuscripts for publication, and presented more than 40 papers in Denmark, Germany, Sweden, UK, Italy, Ireland, USA, and Finland. In short, it has been a quite productive year. The highlights of the year can be found listed below in sections 4 and 6.

4. Research

The research at the Center has followed the guidelines laid down in the Center's research plan, and has been conducted from three different perspectives: 'Phenomenology and philosophy of mind', 'Philosophy of religion and hermeneutics', and 'Psychopathology'.

A. Philosophy of mind and phenomenology

Dan Zahavi has primarily worked on the following projects:

1. A critical discussion of David Chalmers' distinction between the 'easy problems of consciousness', i.e., the problem of intentionality, and the 'hard problem of consciousness', i.e., the nature of phenomenal awareness and the first-person perspective (*The Conscious Mind*, Oxford University Press, 1996). Drawing on reflections found in the phenomenological literature, it is argued that the easy problems of consciousness are either part of the hard problem or not about consciousness at all [cf. research plan section A.IV.].

2. A critical examination of the attempt to bridge the gap between phenomenological analyses and naturalistic models of consciousness that has recently been proposed by Jean Petitot, Francisco Varela, Bernard Pachoud, and Jean-Michel Roy in their book *Naturalizing Phenomenology*, Stanford University Press, 1999. Certain weaknesses in this attempt are identified and an alternative approach is briefly sketched out [cf. research plan section A.II].

3. The contemporary discussion of selfhood is literally bursting with complementary and competing notions of self. Some kind of taxonomy is called for, and it is argued that the three following notions must be differentiated: The *self as a pure identity-pole* (a Kantian suggestion); the *self as a narrative construction* (the hermeneutical suggestion); and the *self as an experiential dimension* (the phenomenological suggestion). A more extensive analysis of the phenomenological notion of self is then undertaken [cf. research plan section B.IV].

4. What is the relationship between phenomenology and metaphysics? Is phenomenology metaphysically neutral, is it without metaphysical bearings, is it a kind of propaedeutics to metaphysics, or is phenomenology on the contrary a form of metaphysics, perhaps even the

culmination of a particular kind of metaphysics (of presence)? It is argued that phenomenology has metaphysical ambitions and implications, and that it is therefore misleading to identify (continental) phenomenology with some kind of introspective psychology [cf. research plan section A.I].

5. In recent years, many scientists have claimed that the core symptoms of infantile autism are due to a deficient neuro-cognitive mechanism that underpins the normal ability to develop a 'theory of mind'. More precisely, infantile autism is taken to involve not only a lack of a theory of other minds, but also a lack of a theory of one's *own* mind (cf. for instance Frith & Happé, "Theory of Mind and Self-Consciousness: What Is It Like to Be Autistic?" *Mind & Language* 14/1, 1999, 1-22). It is argued that much of this discussion is characterized by conceptual confusion, and by the lack of a sound theory of both intersubjectivity and self-awareness [cf. research plan section A.III and A.VII].

B. Philosophy of religion and hermeneutics

Arne Grøn has primarily worked on the following projects:

1. What is the foundation and status of philosophy of religion? As a modern discipline, philosophy of religion deals with the issue of perspective and interpretation of human reality. It is argued that religion is a philosophical challenge in the sense that it is not only part of human reality, but is in itself an interpretation of human reality as such, thereby challenging a philosophical reflection on the nature of perspective and interpretation taken as a core feature of human subjectivity. The basic idea is that in the optics of religion, human existence is seen from *the limit*, understood both as limit situations and the limits of human understanding and action. Human existence is in a radical sense *finite*. The clarification of the foundation and status of philosophy of religion is of fundamental importance for the second part of the research program [cf. research plan B. Introduction and section B.III]. It is to be developed further especially by focusing on the relation between the notion of limit situations and the notion of *conditio humana* [cf. research plan B.VII].
2. A reinterpretation of the notions of infinitude and transcendence. If human existence is inherently finite, what then is meant by transcendence? Influential philosophies in the 20th century translate the concept of transcendence (e.g. as a movement of transcendence, in Heidegger and Sartre, or as an ethical transcendence of subjectivity, in Lévinas). The aim is to offer a critical re-interpretation that shows the strength of the approach developed in 1. Various steps have been taken, first and foremost an investigation of the notion of the movement of transcendence in time, and the corresponding idea of eternity as a depth-dimension of time and history, in a discussion of Michael Theunissen's philosophy of time (in his study *Pindar. Menschenlos und Wende der Zeit*, 2000) [cf. research plan section B.III and B.V].
3. What is the potential of philosophy of religion (as developed in 1) for a theory of subjectivity? Religion is not only subjective, but deals with the problem of subjectivity. The analyses have focused on two points: First, when human existence is seen from the limit or placed in an ultimate perspective, the finitude, contingency, and embodiment of human existence are accentuated. Second, the problem of subjectivity in the optics of religion calls for a philosophical reflection on the complex nature of human subjectivity implied in the interrelation of activity and passivity [cf. research plan section B. Introduction and B.I].
4. The notion of self-relation as a key concept in a theory of subjectivity. One of the basic aims of the second part of the research program is to clarify and analyse the notion of subjectivity as self-relation [cf. research plan B.IV]. The investigations have focused on four steps: First, a discussion of two concepts of the self, self as substance and self as a process, and of the alternative notion of self as self-relation. Second, an analysis of the relation between consciousness and existence. Third, an analysis of the relation between immediacy and reflection, and of the notion of second immediacy. Fourth, an analysis of the subjectivity of imagination [cf. research plan section B.II]. Especially the latter two steps exemplify how the issue of subjectivity is accentuated in philosophy of religion.
5. Ethics and subjectivity of vision. This investigation concerns the issue of inter-subjectivity and normativity [research plan section B.VI], which is to be developed much further.

The dissertation project of *Iben Damgaard* – “Passion of possibility. Subjectivity and possibility from the perspective of hermeneutics and philosophy of religion” – seeks to illuminate the both fundamental and ambiguous role of possibility in human self-relation and relation to God, the world and other persons. This will be explored thematically by focusing on phenomena such as imagination, anxiety, despair, guilt, sin, forgiveness, faith, hope and love and the question of the temporal and ethical aspects of the self. The project is primarily drawing on the philosophy of Kierkegaard and Ricoeur.

The dissertation project of *Wenche Marit Quist* – “Human Being in Time. An Analysis of the Temporality of Existence with continual Reference to Søren Kierkegaard and Martin Heidegger” – is focused on the concept of time in the works of Søren Kierkegaard and Martin Heidegger. Through an analysis of how time must be understood as both a structure for the human existence and as an experience of being human, the concept of time is characterized and thereby seen in the light of basic life phenomena, i.e., guilt, conscience, hope, forgiveness, relation to death, understandings of possibilities in life, anxiety, and boredom.

The dissertation project of *Birgitte Kvist Poulsen* – “Modernity and trinity in G. W. F. Hegel’s Geist-structure” – seeks to clarify the relation between subjectivity and Christianity in the light of Hegel’s Geist-structure. Using the Geist-structure as a prism, the idea is to illuminate this relation, but in such a way that the trinity’s relations provide the background for the understanding of the subject’s relation to God, itself, and the world. Thus, the Geist-structure is seen both as the key to understanding the concept of God, and as the key to understanding the position of human subjectivity.

C. Psychopatology

Josef Parnas has primarily worked on the following projects:

1. Phenomenologically oriented interviews with first admission schizophrenia spectrum patients, with special emphasis on early, non-psychotic anomalies of self-awareness [cf. research plan section C.I].
2. Phenomenological and conceptual analyses of the empirical data collected from first onset schizophrenia spectrum patients with the purpose of defining anomalies of self-awareness, illustrated by prototypical cases, delineation, and differential-diagnostic guidelines. The purpose of this work is to construct a reliable psychometric research instrument to register anomalies of self-experience [cf. research plan section C.I].
3. Statistical analyses of empirical data from relevant groups of patients and cohorts with high familial risk for developing schizophrenia in order to examine relations between different aspects of anomalies of subjective experience, other psychopathological features and extra-clinical measures (e.g. family disposition to schizophrenia, disorders of attention and eye movement) [cf. research plan section C.III].
4. Preparing a new study aiming at first onset schizophrenia spectrum patients with the purpose of examining the correlation between anomalies of self-experience and non-clinical measures such as profiles of neuropsychological dysfunctions, structural and functional brain alterations, and EEG-patterns with or without perceptual stimulation [cf. research plan section C.II].
5. Continuation of Copenhagen Infant Follow-up Study, a longitudinal interdisciplinary prospective study of offspring of schizophrenic mothers, followed from birth until their current age of 13-14 [cf. research plan section C.IV].
6. Preparation of a 4-year follow-up of a group of 155 patients (approximately 100 within the schizophrenia spectrum) in order to assess course, predictive value of disorders of self-awareness and correlations between psychopathological and neuropsychological variables [cf. research plan section C.III].

The focus of *Deborah Licht's* work has been on organising and analysing data from a pedigree study on schizophrenia. The overall goal of analysing and interpreting the data is to explore the schizophrenia spectrum, in order to determine if there is an underlying taxonomic structure in the type of data that has been collected. In particular, one hypothesis to be tested is whether family members with diagnoses within the schizophrenia spectrum exhibit more global thought disorder, more severe thinking disturbances, or a more schizophrenic type of thinking disturbance than members outside the spectrum (family members with other mental illnesses and family members with no mental illness).

The dissertation project of *Anne Vollmer-Larsen* – "Factors in illness development: A follow-up study of first admission patients and previously identified high risk community samples" – aims at identifying the prodromal symptoms that have a predictive value in foreseeing schizophrenia. The hypothesis is that prodromal symptoms such as changes in perception and self-experience are of special importance. The investigation will include a non-psychotic patient population and a non-clinical population with genetic risk of schizophrenia. The hope is that the investigation will improve clinical possibilities of identifying persons at risk for developing schizophrenia and making early prevention possible.
